1. Background

In the event roadmap, D-CENT has listed three project seminars that are organised to raise awareness about the project and boost interaction with our stakeholder groups: launch event, midpoint event and final event. According to the plan, the launch event will be organized in March 2014 (M6), the midpoint event in May 2015 (M20) and the final event in March 2016 (M30).

The Mid-term event titled "Network Democracy for a better city" took place on 5 May 2015 in Barcelona. 22 speakers presented across 4 panels according to the following themes:

- Democratic-common Cities vs Smart-private Cities
- Citizen movements' new generation campaigns in Spain
- Experiments of democratic participation in Cities, A European Perspective
- New political movements for real democracy in Europe

Approximately 170 people attended the event.

2. Objectives

The objectives of the D-CENT mid-term event were to:

Increase awareness of the project among different stakeholder groups.

To bring together experts in the field, civil society and social activists to exchange ideas and to stimulate discussion around democratic participation.

To reach beyond the audience present at the event through social media and by capturing the event through multimedia documentation.

D-CENT is a Europe-wide project creating next generation democracy tools and applications that are decentralised, privacy-aware, and enhance citizens' rights. D-CENT is trying to change the decision-making processes and makes it easier for citizens and social movements to participate in the political process and change things.

On May 5th we will host the D-CENT event under the theme "Network democracy for a better city". The event will take place in Barcelona at CCCB.

This event will draw a number of high-level policy makers, academics, activists, civic society organisations, and hackers to debate the future of democratic City Governments. Together we will dive into new ways of strengthening citizens' participation in the political process presenting already existing digital tools for a more participatory democracy, and discussing how future democratic city infrastructures and governments should look like.

Our discussions will start from the assumption that institutions are in great need of revival since they are out of synchronization with the 21st century technologies, norms and collective aspirations. They haven't been able to respond and adapt to the new technologies of participation, transparency and proximity, which for instance Spanish citizens demanded since the big wave of the 15-M indignados movement in 2011 that radically changed Spanish politics.

The crisis of political representation and legitimacy of current institutions, corruption scandals that unveiled the major political parties' complicity with private interest, and the public disaffection with politics can be addressed by reinventing and reactivating political participation, with concrete proposals to devolve greater control and power to citizens.



Tecnologías ciudadanas descentralizadas para la democracia en red


Tecnologías de Participación Ciudadana Descentralizadas (D-CENT, en sus siglas en inglés) es un proyecto de ámbito europeo que agrupa iniciativas pioneras europeas transformadoras de la democracia en los últimos años y las ayuda a desarrollar la siguiente generación de herramientas libres, descentralizadas y respetuosas de la privacidad para la democracia en red y el empoderamiento económico.

Desarrollo de la experiencia del usuario simple: de necesidades a características reales

En 2014 organizamos talleres con comunidades de usuarios para identificar sus necesidades. Su traducción fueron los primeros productos viables mínimos (PVM) para llevar más allá la plataforma D-CENT, hasta comunidades de España, Finlandia e Islandia.

¿A qué se dedica D-CENT?

D-CENT permite debatir y compartir contenidos, participar en deliberaciones a gran escala, elaborar políticas colaborativas y votar. D-CENT está basado en una arquitectura distribuida, federada y respetuosa de la intimidad. La plataforma modular incluirá herramientas de código abierto para la democracia en red: deliberaciones a gran escala, debates, votaciones, elaboración de políticas colaborativas y algoritmos de filtrado colectivos.

Experiencias piloto, España: Podemos y Barcelona En Comú

Desde la eclosión del movimiento de los Indignados (15M), España está viviendo la emergencia radical de iniciativas políticas encabezadas por la ciudadania, con la participación de toda la sociedad. Los nuevos partidos políticos como Podemos y la nueva ola de iniciativas ciudadanas municipalistas como Barcelona En Comú y Ahora Madrid expresan un nuevo tipo de política, que se caracteriza por la priorización de la democracia participativa, el empoderamiento ciudadano y la justicia social.

Colaboramos con Podemos y Barcelona En Comú, una iniciativa municipal emergente de movimientos ciudadanos y de la sociedad civil. Mediante las herramientas de D-CENT, se involucra a la ciudadania para que participe en el programa político de la iniciativa y en la elección de candidatos/as.

En la actualidad, D-CENT lleva a cabo experiencias piloto a gran escala, en colaboración con Laboratorio Democrático, un laboratorio estratégico digital que administra la infraestructura participativa a nivel nacional y municipal de Podemos.

Estamos desarrollando nuevos prototipos y herramientas con expertos y ciudadanos para que puedan participar en los procesos de elaboración de políticas, desde iniciativas ciudadanas y desarrollo de políticas colectivas, hasta importantes debates y votaciones a gran escala.

Experiencias piloto, Finlandia: Open Ministry y Ciudad de Helsinki

En Finlandia, D-CENT encabezará nuevas herramientas de crowdsourcing con Open Ministry. Éstas asistirán a las personas participantes en campañas de Citizens Initiative en la organización de sus operaciones.

El proyecto también pondrá a prueba un canal de noticias basado en datos para la toma de decisiones con el que los y las habitantes de Helsinki podrán participar ágilmente en acciones colectivas eficaces para responder a los temas procesados en los organismos decisores de Helsinki City. La experiencia, que arrancó en noviembre de 2014, sigue en marcha.

Experiencias piloto, Islandia: Mejora de las herramientas de la democracia electrónica

La experiencia piloto islandesa utiliza el software gratuito de democracia electrónica Your Priorities, que lleva centrando su desarrollo en el usuario simple en Islandia desde 2008, de la mano de la Fundación Citizens, entre otras entidades. La experiencia piloto islandesa girará en torno al perfeccionamiento de Your Priorities añadiendo las funcionalidades que requieren los usuarios de Better Reykjavik y Better Iceland. El objetivo es presentar Your Priorities como una aplicación Docker que pueda instalarse en un nodo de D-CENT para que otros gobiernos, grupos o ciudadanos de toda Europa lo puedan desplegar y usar fácilmente.



Modular, distribuida y de código abierto

La arquitectura de la plataforma D-CENT es modular y respetuosa con la privacidad. Está basada en un software de código abierto y unas normas abiertas. El código está publicado en Github.

Los principios de D-CENT

- propiedad comunitaria de los datos sociales
- seguridad y privacidad desde el diseño
- estándares abiertos
- acceso al conocimiento y código abierto
- gran escalabilidad

Investigación multidisciplinar

La investigación de D-CENT se ha centrado en las nuevas formas de democracia, empoderamiento y participación de la ciudadanía. Se ha llevado a cabo un análisis tecnosocioeconómico de los modelos organizativos de movimientos sociales emergentes, nuevos modelos económicos basados en el patrimonio común de conocimientos, redes sociales distribuidas, sistemas identitarios, nuevos modelos para el control ciudadano de los datos personales y sociales, así como privacidad y seguridad desde el diseño.

Al desarrollar un marco técnico-social de inteligencia colectiva, el IN3-UOC y Barcelona Media han analizado los movimientos de redes globales y han generado perspectivas basadas en los datos para D-CENT.

Investigación de la moneda digital social y pilotos

El Centre d'Économie de la Sorbonne, Nesta y Dyne investigaron las experiencias más significativas de divisas alternativas y divisas sociales digitales en Europa, a la luz de la revolución Bitcoin. La labor con las divisas sociales digitales se llevará más allá, mediante un proceso iterativo con los usuarios principales. Las experiencias piloto con la divisa social digital arrancarán en junio/julio de 2015, y la tecnología blockchain para gestionar la confianza, la reputación y los intercambios comunitarios se integrará como servicio en la plataforma D-CENT.

Divulgación y difusión

Desde octubre de 2013, D-CENT ha publicado informes de investigación públicos y disponibles en nuestra web. Dichos informes incluyen análisis profundos y descripciones de las investigaciones, metodología, arquitectura técnica, casos de uso, características técnicas y actividades de difusión.

En marzo de 2014, en el acto de lanzamiento de D-CENT, "Democracy reboot: Re-imagining democracy and currency in Europe", se presentó el proyecto al gran público. Acudieron responsables de políticas de alto nivel, académicos, activistas, comunidades y hackers. En la web hemos publicado veintitrês videos de entrevistas de ese día. En mayo de 2015, Barcelona acogerá el "D-CENT mid-term event", durante el cual se debatirá sobre la Democracia en red para un nuevo gobierno de las ciudades.

El equipo de D-CENT ha asistido a otros acontecimientos, entre ellos el Foro Mundial de la Democracia 2013, el Open Knowledge Festival 2014, el Congreso CAPS2020, el Foro de Gobernanza en Internet 2014 en Estambul, el W3C20 Anniversary Symposium y Future-Fest 2015.
